Requirements for New Membership

The Following Documents are required to obtain New Membership

1. In case of Proprietorship Concern the following documents are required:

- i) Membership Form must be Filled/Typed in capital letters.
- ii) Copy of CNIC (National Identity Card).
- iii) Copy of National Tax Number (NTN). (Bring original for verification; it will be returned after checking).
- iv) Attach a Company Request Letter with the application form.
- v) Complete company address (Street No., House No., Area, and nearby well-known landmark must be mentioned).
- vi) Bank Account Maintenance Certificate.

2. In case of Partnership Concern the following documents are required:

- i) Membership Form must be Filled/Typed in capital letters.
- ii) Copies of CNIC of all partners.
- iii) Copy of Partnership Deed.
- iv) Copy of Form-C.
- v) NTN of the firm and copies of NTN of all partners. (Bring originals for verification; they will be returned after checking).
- vi) Attach a Company Request Letter with the application form.
- vii) Complete company address (Street No., House No., Area, and nearby well-known landmark must be mentioned).
- viii) Bank Account Maintenance Certificate.

3. In case of Limited Company the following documents are required:

- i) Membership Form must be Filled/Typed in capital letters.
- ii) Memorandum & Articles of Association (signed by all directors).
- iii) Copy of Certificate of Incorporation.
- iv) Copies of CNICs of directors.
- v) Copy of NTN. (Bring original for verification; it will be returned after checking).
- vi) Attach a Company Request Letter with the application form.
- vii) Complete company address (Street No., House No., Area, and nearby well-known landmark must be mentioned).
- viii) Bank Account Maintenance Certificate.

Note:

- ★ Verification from two firms with official stamp is mandatory.
- ★ The verifying person must be an authorized representative, and their firm's membership must be valid/renewed.
- ★ Overwriting on the membership form is not acceptable.
- ★ Before completing the formalities for registration of a new firm with the Pakistan Gloves Manufacturers & Exporters Association (Sialkot), please get your firm name checked with the Membership Department to avoid any inconvenience later.
